Other sector chairpersons shared their visions for their respective sectors and reaffirmed their commitment to working closely with the government to address challenges and improve operational efficiencies in their sectors.

During the meeting, the respective sector chairpersons provided comprehensive overviews of the current state of their sectors, identifying key challenges and outlining strategies for future development. Mr. Nwako emphasised the organisation's ongoing commitment to working with the government to improve the ease of doing business in Botswana. He expressed optimism that the issues faced by various sectors would be addressed effectively, paving the way for a more conducive environment for private sector growth.

## BUSINESS BOTSWANA CEO ENGAGES RURAL DEVELOPMENT COUNCIL SECRETARIAT ON ENHANCING RURAL GROWTH

Business Botswana CEO and Rural Development Council (RDC) board member, Mr. Norman Moleele, recently met with the RDC team to discuss the growth and facilitation of rural councils in Botswana. The meeting aimed to assess whether the current investment incentives adequately support rural development and explore new strategies to attract businesses to rural areas.

During the meeting, Mr. Moleele provided an overview of Business Botswana's mandate, emphasising the organisation's commitment to facilitating private sector growth across the nation. He highlighted the network of Business Councils, now established in 15 localities, which serves as a vital platform for businesses to engage with the government through the Local Level Consultative Council (LLCC).

These councils work to address both opportunities and challenges faced by businesses within their respective regions, playing a key role in driving local economic development.

The discussion also delved into the challenges surrounding the implementation of existing investment incentives, particularly regarding procurement processes for businesses in rural areas. Mr. Mpaphi Tsholofelo, Head of Policy and Research at Business Botswana, noted that regional-specific incentives are essential, particularly for localities with a strong sectoral presence, such as agriculture in Ghanzi Region. Tailoring incentives to the strengths of different regions could unlock significant growth potential.
